Senior Appointments will aid Growth of new Business Area

of a biomass energy support scheme, as well as the development of a strategy for the Crown Estate to tackle residual liabilities from offshore renewable energy installations.

Mr Gasharov, who has particular expertise in carbon reduction programmes, joins from a sustainable development consultancy. His previous experience has ranged from developing sustainability policies for public sector organisations and large corporates to training local authority staff in carbon management programmes and leading large scale refurbishment schemes to integrate low energy products into ageing housing stock. He has also managed ground-breaking projects, including a scheme to integrate wind turbines into a group of tower blocks in Bradford, and led awareness-raising programmes, such as the Cambridgeshire Energy for Good Scheme and the Oxford Solar Initiative, designed to encourage local residents and businesses to adopt low carbon technologies and energy efficiency measures.

Chris Green, Chief Executive Officer of SQW Group, said: "With climate change clearly emerging as the greatest challenge facing UK and international governments in the 21st century, the energy, environment and sustainable development agenda is a top priority for our public and private sector clients. It will need to be pursued alongside a continuing commitment to economic development and regeneration, recognising the tensions - and also the opportunities -that this is likely to generate.

"The UK government's framework to tackle climate change, establishing a carbon reduction pathway to 2050, has significant implications for public sector policies to encourage sustainable economic development and regeneration. As well as adopting exemplary practices itself, the public sector is expected to promote changes, via its strategies and programmes, throughout the rest of the economy.

"The energy sector also faces challenges as the UK's power stations and distribution networks are ageing and operate within a complex mix of regulation and competitive markets. Decisions on new investments with an operational life of over 40 years are not taken lightly and assistance with corporate strategies that can deliver on both commercial priorities and energy and environmental targets is needed.

"SQW has a long track record of supporting clients to meet these kind of challenges

of the future and our new appointments are part of our commitment to expansion of

our energy, environment and sustainable development services. Chris, Gavin and

Assen are valuable additions to the firm who will ensure that we can continue to

provide high quality and practical assistance to our clients."
